4) Minutes

It was **resolved** to approve the minutes of the previous meeting of the Parish Council of Monday 13 July 2015 and these were signed, as an accurate record of the meeting.

5) Adjournment of up to 15 minutes for members of the public to raise matters

Members of the public explained their objections to planning application PA15/07433.

The agent for planning application PA15/07433 clarified aspects of the proposed development. Members of the public and a trustee of Sterts Theatre voiced their objections to this application.

Councillors raised questions to seek clarification.

6) Reports from and matters of concern to:

- a) Police representative of 'Liskeard Have Your Say' (LHYS) unavailable
- b) Cornwall Councillor McWilliam

Cornwall Council has been in discussion with charities working with refugees to seek ways of lending assistance. Cornwall might not be suitable for housing refugees, especially children, since it would be unable to offer language support, housing, and schools.

CCIIr McWilliam informed members that Cornwall CIIrs have no role in enforcement, only determining planning applications. This was queried by two members; at District, a committee judged on enforcement, and one view expressed that it should not be determined by planning officers.

She was pleased that CCIIr Geoff Brown had paid a visit to Upton Cross library. There are no further developments on the 'Deal for Cornwall'.

There was no further news regarding a new Chief Executive. It is anticipated that a short-list would be compiled by mid-November, ready to put recommendation to the panel on 24 November 2015.

CCIIr McWilliam was thanked for organising the visit to the library and for presenting her report.

7) Planning

Clirs Hopes and Lobban departed the meeting

a) Planning Applications

Proposed, seconded, and upon being put to the vote it was **Resolved** that the following recommendations be submitted:

i) PA 15/07168 Provision of garage/workshop/change use of field to domestic at Treja, Liverscombe

to object to the application for the same reasons given in the Parish Council's response to the previous application, PA15/04407, notwithstanding efforts made to address concerns regarding materials and drainage, and recommends that the application be refused.

Clirs Hopes and Lobban returned to the meeting

ii) PA15/07433 outline application for 14 residential units to include affordable and open market homes, at Little Upton Farm, Upton Cross

to object for the same reasons as submitted in relation to PA15/04485, notwithstanding the increase in percentage of affordable housing and the support from Cornwall Council Highways, namely:

that whilst the support of the Affordable Housing team is acknowledged, the Council considers that there is insufficient regard given to the affordable housing-led element, i.e. 50-50 does not indicate '-led';

that the location of the proposed development lies beyond any appropriate boundary for development of the village and represents a stretching away from the main village. This indicates insufficient regard to a resilient and sustainable village centre;

that it will have an adverse impact on amenity and therefore social cohesion both for residents of the proposed development and for the existing neighbouring land users, namely a working, livestock farm and associated noise and smells, which abuts the site, and the open-air theatre of Sterts, the development consent for which was premised on its remote location in order to mitigate noise, nuisance, and increase of vehicular movement;

that it will have an adverse impact on the character and setting of the adjoining listed property;

that concerns remain, despite the view of Highways, regarding road safety in the vicinity of the proposed development.

iii)PA15/06522 LBC various works to farmhouse and coalhouse at Cheesewring Farm, Minions – to support

iv) PA15/06738 Regularisation of single-storey extn at Ridgeway Cottage, Minions – to support

 - i) It was **resolved** to request provision of a 'package' instructing councils on technological requirements for moving to digital planning considerations, and for Cornwall Council Planning to develop a proper structure of filing for ease of downloading documents, to copy to CCIIr McWilliam and Sheryll Murray MP ii) It was **resolved** to consider future process once the above is properly in place

8) Finance

 It was **resolved** that the bank reconciliation statement represented an accurate account, and this was signed by the Chairman.

 - i) In accordance with the provisions of Minute 7(f)/2015-177 to acknowledge and endorse the submission by the Council of an application to Awards for All in connection with a scheme for the provision of play equipment at Jubilee Field, it was **resolved** to accept terms and conditions.
 - ii) **Resolved** that consideration of management of obligations be deferred until proposals have been formulated.

9) Play Areas and Equipment

a) Weekly safety inspection i) Jubilee Field ii) Rilla Mill Play Area. Weekly inspection check sheets for August were submitted to the Clerk

10) Neighbourhood Development Plan

a) Members read the progress reports and were invited to suggest other aspects for consideration in the NDP. Conservation was defined as conservation of the built environment; it was suggested that it should include conservation of landscape/natural environment.

11) Public Conveniences

a) Members learned that Cllrs Hopes and Ward would be meeting in early October with CCIIr Duffin and Jon James to discuss possible options for future provision Upton Cross/Minions. Members were invited to define possible solutions for Cllrs Hopes and Ward to discuss. Questions raised but no firm solutions were forthcoming at this stage.

12) Bin for dog waste

a) Provision of a dog waste bin in Upton Cross and at other locations in the parish was discussed, and hearing of the experiences of other authority areas it was **Resolved** that the Parish Council would not proceed with providing bins, due to prohibitive cost of purchase and supporting service across the parish, and Cornwall Council accepts dog waste in existing litter bins.

13) Minions sign at Minions

a) **Resolved** that Cornwall Council be invited to restore the original sign and find suitable location elsewhere for the Minions sign.

14) Litter Pick

a) The Parish Council was pleased to hear that Caradon Archaeology will be litterpicking, with the permission of landowners, on the moor in October.
