#### 3) Code of Conduct:

#### 4) Minutes

It was **resolved** to approve the minutes of the previous meeting of the Parish Council of Monday 9 February 2015 and these were signed, as an accurate record of the meeting, subject to the following amendments: Item 2 delete 'Cllr Ward';

It was noted that the crime figures did not include a crime of a trailer theft which had been reported. The meeting also heard that local landowners had, when challenging individuals acting suspiciously on farm premises, been asked for scrap metal. It was agreed to send a copy of the minutes to Mr Wooster.
