- i) PA12/06574 Extension to include function/games room at Cheesewring Hotel, Minions to **support** (unanimous)
- ii) PA12/04756 single storey rebuild of derelict shed at Heather House, Pensilva (nr Wheal Tor) to **support** subject to granite or similar, appropriate local stone to match existing, and to the use of less visually intrusive material for the roof.
