ii) PA11/04226 Renewal of consent for temporary agricultural worker's dwelling at Little Lanhargy, Bray Shop – approval

iii) PA11/04483 Construction of rear garden room with balcony over at Fourways, Upton Cross – refusal with 2 abstentions. Concerns were expressed regarding both the visual impact of the flat roof, particularly given that the trees shielding the end of the house have now been removed, and the loss of privacy to the neighbouring property. It is contrary to the Caradon Design Guide.

iv) PA11/02752 Extension to buildings for expansion of milk processing business at Knowle Farm, Upton Cross (Cornish Cheese Co) – approval, subject to the appropriate development of the access to the B3254 quoted in the application.
